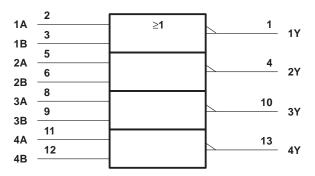

The SN54F02 is characterized for operation over the full military temperature range of -55°C to 125°C. The SN74F02 is characterized for operation from 0°C to 70°C.



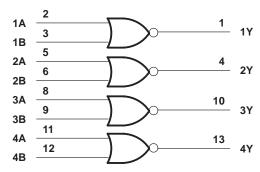

## logic diagram (positive logic)



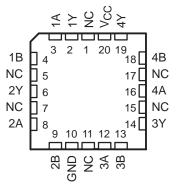
